### Notice Regarding Acquisition of Shares of Reflector Entertainment (Becoming a Subsidiary)

BANDAI NAMCO Holdings Inc. ("the Company") hereby announces that in accordance with the resolution passed at the Board of Directors meeting held on September 16, 2020, the Company's consolidated subsidiary BANDAI NAMCO Entertainment Europe S.A.S. ("BNEE"), which belongs to the Network Entertainment Unit, concluded an agreement to acquire 100% of the issued shares of Reflector Entertainment Ltd. ("Reflector"). As a result, Reflector will become a subsidiary of BNEE, and it is expected to qualify as a specified subsidiary since its amount of capital is equivalent to 10% or more of the Company's amount of capital. The details are as follows.

# 1. Aims

In accordance with our three-year Mid-term Plan started in April 2018, the BANDAI NAMCO Group is strengthening the IP Axis Strategy in the global market, continuing to empower, gain momentum, and accelerate evolution without being bound by previous business models and established ideas, and aiming for the next stage as an entertainment company.

Currently, the Network Entertainment Business, in order to increase the presence of the home video game business and network content business in the global market, is working to improve the quality of its titles, enhance the development system and strengthen its marketing.

Reflector possesses high technical development capabilities in the development of home video game titles, and is currently developing the new title "Unknown 9: Awakening" in partnership with BNEE. Through this share acquisition where Reflector, an important business partner of BNEE, will become a subsidiary of BNEE, the Company aims to build a portfolio of home video games for the Americas and Europe with a proper balance of Japan-developed and locally developed titles by strengthening the development system necessary to create and expand locally developed home video game titles.

Reflector is planning to merge with its subsidiary Reflector Interactive Productions Ltd. according to Canadian law, and BNEE plans to acquire Reflector's shares after this merger.

Furthermore, as this acquisition is an investment from outside of Canada, the Company will carry it out upon receiving approval from Canadian authorities.
