INDEPENDENT ASSURANCE STATEMENT

To: Bandai Namco Holdings Inc.



Bureau Veritas Japan Co., Ltd. (Bureau Veritas) has been engaged by Bandai Namco Holdings Inc. (Bandai Namco Holdings) to provide limited assurance and to conduct an external review over sustainability information selected by Bandai Namco Holdings. This Assurance Statement applies to the related information included within the scope of work described below.

Selected information

The scope of our assurance work was limited to assurance over the following information included within the Bandai Namco Holdings Sustainability Website ("the Website") or reported internally to Bandai Namco Group only for the purpose of internal management for the period of April 1, 2023 through March 31, 2024 (the 'Selected Information'):

The following environmental performance data of sites within Japan

- Energy usage
- CO₂ emissions
- Water intake and Wastewater
- Waste discharged and Waste recycled
- Copy papers usage

Note: The reporting boundaries for each data are defined by Bandai Namco Holdings.

The scope of our review work was limited to review about the following information included within the Bandai Namco Holdings Sustainability Website ("the Website") or reported internally to Bandai Namco Group only for the purpose of internal management for the period of April 1, 2023 through March 31, 2024 (the 'Selected Information'): The following environmental performance data of sites outside Japan

- Energy usage
- CO₂ emissions
- Water intake and Wastewater
- Waste discharged and Waste recycled
- Copy papers usage

Note: The reporting boundaries for each data are defined by Bandai Namco Holdings.

Reporting criteria

The Selected Information included within the Website needs to be read and understood together with the reporting criteria stated in the Website.

The Selected Information reported internally to Bandai Namco Group only for the purpose of internal management needs to be read and understood together with the internal reporting criteria defined by Bandai Namco Holdings.

Limitations and Exclusions

Excluded from the scope of our work is any verification of information relating to:

- Activities outside the defined verification period;
- Any other information within the Website, which is not listed as the 'Selected Information'.

This limited assurance engagement relies on a risk based selected sample of sustainability data and the associated limitations that this entails. This independent statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

Responsibilities

This preparation and presentation of the Selected Information in the Website are the sole responsibility of the management of Bandai Namco Holdings.

Bureau Veritas was not involved in the drafting of the Website or of the Reporting Criteria. Our responsibilities were to:

- Obtain limited assurance about whether the Selected Information has been prepared in accordance with the Reporting Criteria by conducting our assurance work;
- Assess the reliability and accuracy of the Selected Information by conducting our review work;
- Form an independent conclusion based on the procedures performed and evidence obtained; and
- Report our conclusions to the Directors of Bandai Namco Holdings.

Assessment Standard

We performed our assurance work in accordance with International Standard on Assurance Engagements (ISAE) 3000 (Revised), Assurance Engagements Other than Audits or Reviews of Historical Financial Information (Effective for assurance reports dated on or after December 15, 2015) issued by the International Auditing and Assurance Standards Board.

For the greenhouse gas emissions data, we undertook verification in accordance with the requirements of ISO14064-3 (2019): Greenhouse gases - Part 3: Specification with guidance for the verification and validation of greenhouse gas statements. We performed our review work by using Bureau Veritas' standard procedures for external review of sustainability information.



Summary of work performed

As part of our independent verification, our work included:

- 1. Conducting interviews with relevant personnel of Bandai Namco Holdings;
- Reviewing the data collection and consolidation processes used to compile Selected Information, including assessing assumptions made, and the data scope and reporting boundaries;
- 3. Reviewing documentary evidence provided by Bandai Namco Holdings;
- 4. Reviewing Bandai Namco Holdings systems for quantitative data aggregation and analysis;
- 5. Verification of sample of data back to source by carrying out five physical site visits, selected on a risk based bases at the following companies:
 - Bandai Namco Holdings Inc. Head Office
 - Bandai Namco Amusement Inc. namco OSC Shonan City
 - LOGIPAL EXPRESS INC. Odaiba Sales Office
 - Bandai Namco Filmworks Inc. White Base, Fujisawa Bldg
 - BANDAI CO., LTD. Head Office
- 6. Reperforming a selection of aggregation calculations of the Selected Information;
- Comparing the Selected Information to the prior year amounts taking into consideration changes in business activities, acquisitions and disposals.

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

Verified greenhouse gas emissions

We performed our verification work on greenhouse gas emissions data in accordance with the requirements of ISO14064-3(2019).

Verified data in greenhouse gas assertion made by Bandai Namco Holdings are as follows.

- Nothing has come to our attention to indicate that the Selected Information has not been properly prepared, in all material respects, in accordance with the Reporting Criteria;
- It is our opinion that Bandai Namco Holdings has established appropriate systems for the collection, aggregation and analysis of quantitative data within the scope of our work.
